they didn't show up for work and that a note was found which caused concern for their well being. Both were found dead in their bed. It was apparent that Derrick Maylock shot his wife and then shot himself. A note was left by the male victim indicating that he had become despondent over financial and health issues.

Burglary at 400 block Olympic Avenue on 3/23 @ 1237 hours – victim returned home and heard his trash cans being knocked over. He saw two black males on the side of his house. He then noticed his side door glass was broken. He then called 911. Both actors were located. [Roland Loftin and Artor Todd](#) were charged with burglary and related charges.
