4th Ward Constituent Town Meeting on May 13, 2009 at 7:30 p.m. Your Opportunity to Ask Questions & Speak Your Mind

On Wednesday, May 13, 2009 at 7:30 p.m., I will hold a 4th Ward Town Meeting to provide *you* with an opportunity to meet with Township Manager Lawrence Gentile, Assistant Township Managers Lori Hanlon-Widdop and Tim Denny, Police Chief Carmen Pettine and me. The meeting will be held at the Quatrani Building located behind the Township Building at 2325 Darby Road in Havertown.

The purpose of the Town Meeting, which I hope to hold twice a year, is to allow 4th Ward residents to air their questions and concerns, and to receive answers to those questions. Because the 4th Ward includes portions of Lawrence, Eagle and Darby Roads, I receive more calls (and complaints) about traffic and speeding throughout the Township, and especially in our Ward, than about any other issue.

The problem is very serious, because not only do cars speed on the major roads, but they also use our residential streets as “cut throughs.”

As a result, I am working with the Police Department to address your concerns. Of course, I do not know where all of the problems are, nor is it possible for the police to be everywhere all the time. But, if they learn about the problem areas, they can try to help.

Please feel free to contact me about specific problems, and I will do what I can to assist you. Remember, please do your part as well. Obey the posted speed limits so that our Township is safer for everyone, including pedestrians and school students.

Trash & Recycling Reminders From the Public Works Dept.

To assure that all of your trash, recycling and lawn waste are picked up, please remember:

- No items can be over 3 feet long
- No trash cans or bags should weigh more than 40 pounds
- Nothing should be sticking out of your trash cans, such as long branches
- Recycling cans, and cans with recycling stickers, must be used for RECYCLING ONLY, not for trash
- For all plastic recycling, if the neck of the bottle/jar is smaller than the bottom, it is recyclable; otherwise it should go into the trash

Free Notary for 4th Ward Residents

A Message from the Township Manager



I would like to express my sincere appreciation to all Haverford Township residents, the Board of Commissioners and our employees for their support and contributions towards the success of the new Haverford Township Single Stream Recycling program. Since its inception on January 1st, the Program has reduced total sanitation solid waste by 1,309 tons and diesel fuel usage by 619 gallons. In just two months, we have reduced the Township's operating costs by \$23,166.00.

In an effort to find additional Township savings, we have researched the feasibility of changing our leaf collection system and are developing a collaborative relationship with Marple Township, including the purchase of a leaf composting system. This new equipment, to be shared by both communities, will achieve substantial savings. Currently, the Township devotes 1000s of work-hours and spends over \$500,000.00 annually to dispose of the mountains of leaves that residents and landscapers put in the streets. Our Public Works Department uses multiple trucks, large vacuum machines and front-loaders, and burns hundreds of gallons of sooty diesel fuel to complete this job.

Each year, 100s of truckloads of leaves are picked up from our streets. The Public Works Department transports over 3,350 tons of leaves to the Delaware County Municipal Waste Facility in Chester. This year, each municipality in Delaware County must pay to dispose its leaves; this will cost Haverford Township over \$100,500.00. Leaf pickup and disposal is expensive and we believe strongly that changing the leaf collection process and implementing this new composting system will save 1000s of dollars for our residents.

As with most local governments, Haverford Township finds itself directly affected by the same economic conditions and trends impacting all Americans. For this reason, my principal goal in operating the Township is to stabilize us from both a functional and a financial standpoint. To do so, we will continually search for new opportunities to reduce municipal operation costs while improving the services to our community.

I can assure each resident that my main goal is to ensure that our community is a safe, healthy and fun place to live, which provides services in the most cost effective manner feasible.
