## Preface

The Township of Haverford Police Department for the past twenty years has been undergoing a philosophic transformation. This transformation continued throughout 2008. In an effort to better serve our community the department has moved from a reactive police force to a proactive department that works in partnership with the community. The goal of this partnership is to deliver the highest level of police service possible to Haverford Township, its residents, businesses and the citizens of our larger community. This annual report is a reflection of our efforts.

This year brought change to the police department. We moved from a self-contained twenty-four hour a day emergency communication center to being dispatched by the Delaware County Communications Center. This undertaking required a coordinated effort between the police department, fire and emergency medical services, our elected officials, neighboring departments, and the County Communications Center. This transition is a multi-phased project with the initial phases having been implemented in 2008. These phases included planning, coordination and the physical transfer of emergency communications and dispatching to the County Communications Center. The transfer of services and first emergency dispatch took place on November 5, 2008.

The remaining phases of transfer continue to take place with the installation of hardware and creation of the Sector 7 radio system. This sector will combine the Haverford and Radnor emergency services and enhance the interoperability of those agencies.

We also saw the department make a change in the duty weapon carried by all officers. The standard issue Beretta 92 that was utilized by this department for the last decade gave way to new technologies in firearms systems. The transition to the Beretta Storm firearms system allowed this department to increase officer safety, while at the same time providing state of the art equipment to all officers in a format that was already familiar to them.

This year the department completed the records management system upgrade that allows officers full report writing and information access capability in a mobile environment. The police officer no longer needs to take time from his patrol responsibilities to return to the station to write a report. The officer can now access data along with timely pertinent information, resolve the call and complete the report all from his area of assignment by utilizing the patrol vehicle capabilities.

Our most significant change this year was our change in leadership. The retirement of Chief Gary E. Hoover and swearing in of Chief Carmen D. Pettine epitomized our year of change.

Chief Hoover served our community and department for 39 years with honor and distinction. His tenure began this department's transition from a reactive enforcement model to the more service oriented proactive community first philosophy that we operate under today. Chief Hoover was instrumental in the implementation of several community based strategies such as our school based initiatives, traffic safety and calming initiative, youth aid panel and crime prevention services.

Due to the strong commitment and belief in the core values of these programs our officers were able to maintain a high level of service during our transition into the new administration. With the swearing in of Chief Pettine in late 2008 it is clear that he will bring new energy and ideas to this department. While Chief Pettine mirrors many of the same values and commitment to the community based philosophy that this department utilizes he also has brought with him 21<sup>st</sup> century concepts in local policing.

Chief Pettine has already begun to enhance the department's commitment and capabilities by renewing and initiating several programs. From this Annual Report that calls for an internal look at our mission and results to the upcoming firearms training at a state of the art range, this department is poised for a year of reinvigoration and rededication to community service.

## Mission Statement

The mission of the Haverford Township Police Department is to improve the quality of life throughout the Township by providing a secure community environment through the delivery of police services in an efficient and effective manner.

We, the Haverford Township Police Department, are dedicated to protecting all persons, and fostering a positive relationship of cooperation and understanding between the Police Department and the citizens of Haverford Township.

We shall strive to establish a climate of mutual respect and trust through positive interaction with citizens of the community and by maintaining a community oriented policing philosophy.

## Departmental Organization and Staffing

*The Department has three divisions and a total complement of one hundred and seventy two sworn and civilian personnel.*

**T**he Township of Haverford Board of Commissioners established a Night Watch and Police Force June 5, 1916. When Ordinance number 77 of 1916 passed it did “ordain” the Night Watch and Police Force would consist of one Chief of Police and not more than nine Policemen, one of whom may be appointed Sergeant of Police.

**Our Departmental history** shows the first Chief, Edward F. Hallisey, and the five officers initially hired did not have long lived or prosperous careers. The Chief left the Department after only three years and ten months of service. His first recruits fared far worse. The first officer hired by the Township, George T. Neeli lasted ten days and the second officer hired completed four months. This four month stint was three months longer than any of his fellow hires.

Ordinance number 77 also outlined the officers’ duties. “Policemen shall patrol their respective beats during all of the time they are on duty and shall be governed in making arrests of all drunken, disorderly and suspicious persons by the laws of this Commonwealth, and by the Ordinances and Regulations of the Township. It shall also be the duty of Policemen to inspect the street lights maintained by the Township and to immediately report any lights not in good order and further to inspect all poles, lines and overhead wires and all streets and roads containing water, gas or other pipe-lines and to immediately report any defects therein or dangerous condition caused thereby...”

**Today** our Department consists of one Chief of Police, seventy sworn officers and one hundred and two civilian personnel. The civilian personnel consist of five information assistants, one administrative assistant, one records office manager, two secretaries, two full time records clerks, two part time records clerks, seven meter enforcement officers and eighty two crossing guards. Of the seventy officers one is a Deputy Chief, three are Lieutenants, twelve are Sergeants and fifty three are Police Officers. Over

the last twenty five years this Department has hired 87 officers. All of those hires have either retired or remain actively employed by the department with the exception of 18 officers. Those 18 officers served an average of 6  $\frac{3}{4}$  years with the three longest serving officers completing 16 years of service. Seven of the officers left the department to work for other Law Enforcement agencies.

In the last one hundred years not only has officer retention drastically improved but the education and certification the officers possess is unprecedented in our department history. In 2008 our seventy officers completed five thousand six hundred and twelve hours of police education.

The department has had twelve Chiefs and three hundred and forty seven officers. Carmen D. Pettine is the twelfth Chief of Police for Haverford Township. Chief Pettine has a strong belief in community based policing and continues to move our department forward from the Night Watch mentality of the first eighty years of our history to an even more proactive, partnership based community policing model we operate under today.

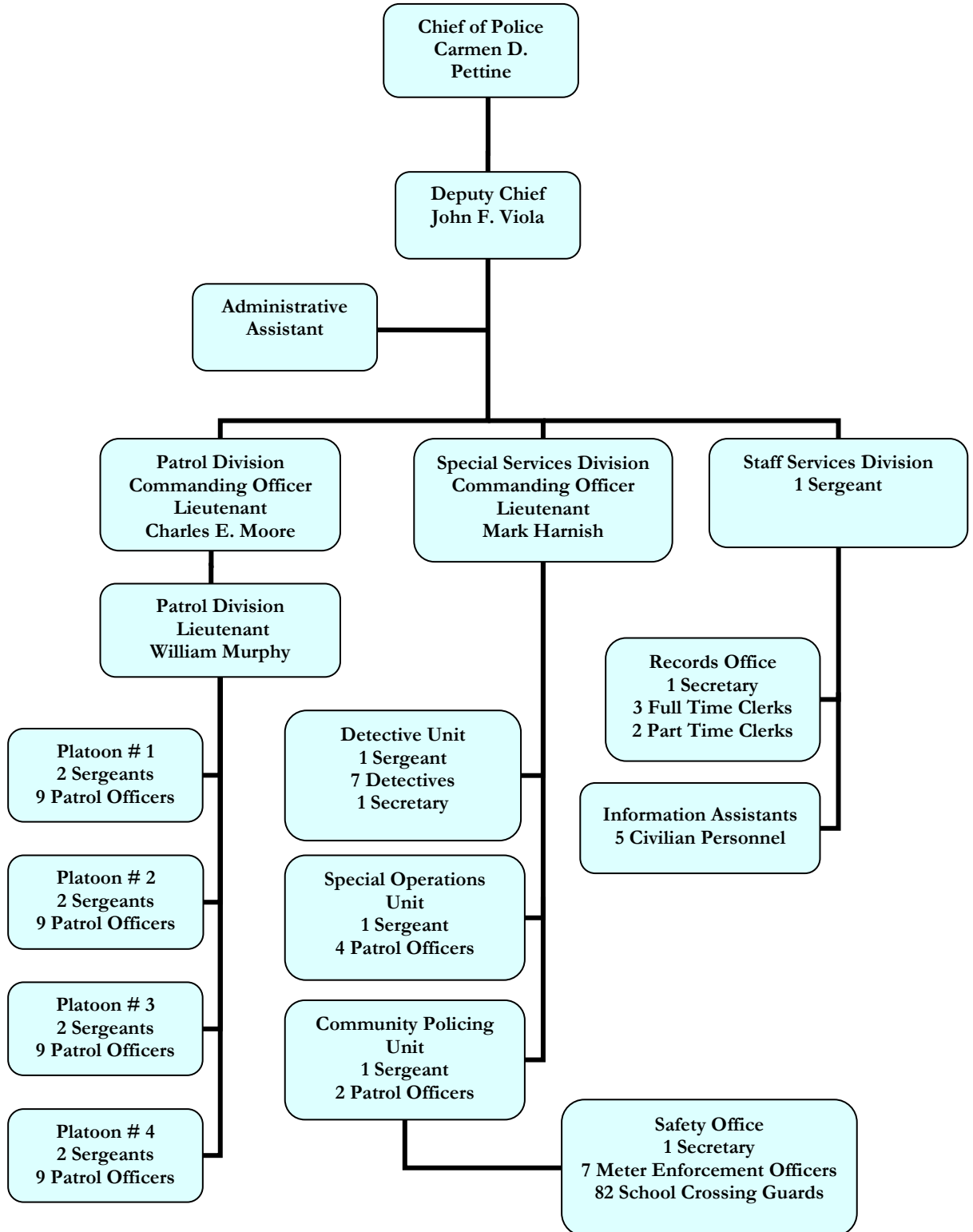

## Patrol Division

**T**he Patrol Division is the backbone of the Haverford Township Police Department. It is tasked with carrying out the basic functions of the police department. While every member of the department is sworn to protect life and property, prevent crime, and arrest violators of the law, it is the members of the patrol division that help to accomplish these goals through routine patrol of geographical areas, responding to emergency and non emergency calls for service, investigating traffic collisions, enforcing the motor vehicle laws, and handling other requests for police services. The patrol division is on duty twenty four hours a day, seven days a week and is staffed by two Lieutenants, eight Sergeants, and forty patrol officers.

**A manpower distribution plan** is used by the Department. The plan utilizes multiple districts along with overlapping sectors. This plan allows the officer assigned to a district to maximize their time in the assigned district. This is accomplished by assigning the sector officer to the back-up role rather than bringing another district officer out of his district to back a fellow district officer.

The plan allows the Department to keep the officers who patrol a district familiar with the people and issues occurring in that district. An Officer is generally assigned to the same district or sector for an extended period of time so they become familiar with the activity in the area. The approach fosters a better working relationship between the community and the officers that can lead to an ownership mentality around the unique issues in their area.

**The Police Department hired** four new Police Officers between December 2007 and December 2008. Officer Stephen Gill, Officer James Reynolds and Officer Brian Coleman were hired in December of 2007. Officers Coleman and Reynolds were assigned to the police department Field Training Officer Program. Officer Gill was assigned to Delaware County Community College Police Academy to receive the required Municipal Police Officers Education and Training Commission certification. He graduated from the Academy in June and was then assigned to the Field Training Officer Program. Officers Gill, Reynolds and Coleman successfully completed their Field Training Program in December and have been assigned to the Patrol Division.

In December 2008 Officer Carmen Balsama was hired and assigned to the Field Training Program.

The Field Training Program is a ten (10) week program designed to prepare a Probationary Police Officer to perform the duties of a police officer in Haverford Township. The new Officer is required to successfully complete a series of performance standards and tasks evaluated by Field Training Officers (FTO) assigned to instruct the new officer in the methods necessary to perform these standards and tasks satisfactorily.

## Special Services Division

**T**he Special Services Division is commanded by one Lieutenant who is responsible for four separate elements; the Detective Unit, the Special Operations Unit and the Community Policing Unit, along with the civilian Safety and Meter Enforcement Office. The Special Services Division Lieutenant is also the Critical Incident Team Commander.

### Detective Unit

**The Detective Unit** is currently comprised of Detective Sergeant Daniel Wallower, Detective Mark Johnson, Detective George Christake, Detective Alan Ross, Detective, Matt Hufnal, and Detective Jere Goodman. The Detective Unit is under the command of Lieutenant Mark Harnish. The Detective Unit conducts follow up investigations on all major crimes occurring in Haverford Township, as well as investigations into other suspicious or criminal activities having sufficient information or evidence which could culminate in an arrest or a clearance of the incident. During the 2008 year the Detective Unit has conducted follow up investigations on 257 incidents culminating in the clearance of 105 of these crimes or incidents.

**This year** the Detective Unit investigated 16 robberies and cleared 15 of these crimes. There were 8 sex offense investigations conducted resulting in 4 clearances, including 3 arrests for sexual assault on juvenile victims. The Department received 29 aggravated assault incidents with 24 of these crimes being cleared. Two of these aggravated assaults involved firearms and three incidents involved the use of a knife. All five of these cases were cleared. The detectives, through excellent investigative work, were responsible for arresting a suspect involved in a shooting during a drug transaction incident. Burglaries remain the number one major crime occurring in Haverford Township. The very nature of this crime makes the crime extremely difficult to clear as little evidence leading to the identity of the suspect is left at the scene. In 2008 there were 94 burglaries reported, with 13 of these crimes culminating in clearances. In December alone the Township experienced a burglary crime spree resulting in 9 of these burglaries. The suspect committing these burglaries was successfully

apprehended as a result of excellent investigative work by the detectives of the unit.

**Juvenile criminal investigations** are also conducted by the Detective Unit. During the 2008 year 63 juveniles were petitioned to juvenile court for offenses ranging from assault with a firearm to burglary, theft, drug violations, and motor vehicle theft. Detectives also conduct investigations into missing juveniles reported to the Department. Another important function of the Unit is the referral of juveniles to the Youth Aid Panel Program. This program is designed to divert first time juvenile offenders away from the formal juvenile court system. The program is applicable to any first time juvenile offender who has committed a relatively minor offense, such as, a curfew violation, some vandalisms, retail theft, underage drinking, etc. During 2008 there were 105 juveniles offered the Youth Aid Panel Program option. The Haverford Township Youth Aid Panel Program has been recognized by the Delaware County Center for Resolutions as a model panel for other panels throughout Delaware and Chester Counties to emulate.

The Detective Unit manpower allocation was reduced by two detectives during the course of the 2008 calendar year as a result of resignations. These two detectives were offered opportunities to work for the Delaware County Criminal Investigations Division in Media, Pennsylvania. The expertise of these detectives was sorely missed, but the remaining detectives have stepped up their efforts and have been successful in bridging the gap created by the loss of these two seasoned detectives.

## Special Operations Unit

**The Special Operations Unit (SOU)** is responsible for many facets in the overall operation of the Police Department. The Unit is staffed by 1 Sergeant and 4 Officers and allows the Department flexibility in deploying officers of the unit for special events, conducting training or other administrative functions without depleting the resources of the regular patrol unit.

**One of the primary responsibilities** of the SOU is fatal (and near fatal) crash investigations, crashes involving police cars, hit-and-run crashes or any other extraordinary crash. Specialized equipment used in those investigations includes Laser Technology's LTI 200 laser measuring device and CAD Zone's Crash Zone diagramming software. All members of the Unit have completed the basic fatal crash investigation classes, and at least one advanced crash investigation class.

In an attempt to prevent crashes, members of the Unit utilize the three E's - Engineering, Education and Enforcement. The engineering facet consists of conducting traffic surveys and making recommendations concerning traffic

patterns and restrictions, i.e., traffic calming. The education facet finds Unit members attending community meetings and listening to their concerns, offering a variety of solutions and working with the Township to complete the task. The enforcement facet is the extremely focused solution to crash prevention. By issuing a citation, the goal of the police officer is to prevent the recurrence of a potentially dangerous behavior. The department participated in two specialized programs, Buckle-Up PA & Smooth Operator, that received both federal and state funding. The primary focus of Buckle-Up is seatbelt usage, and encompasses both education and enforcement portions of the program. Smooth Operator is targeted toward aggressive driving behaviors, and is strictly an enforcement program. During these programs, contact was made with drivers, and officers issued 1,156 citations.

**Officers assigned** to the SOU also conduct firearms training for the police department, as well as other training required by the state and department. In 2008 the department transitioned to a new handgun, the Beretta Px4 Storm, and each officer received 8 hours of familiarization. Additionally, we conducted over 1,570 officer-hours of firearms training and qualification. Intra-departmental training found officers in a classroom for over 1,000 hours consisting primarily of First Aid/CPR. Our Officers attended over 640 hours of instruction outside of the Department in various disciplines related to their responsibilities.

**Additional duties** of the SOU include: Maintaining the training files and certifications for the officers in the department; repairing or facilitating the repair of equipment, from VASCAR units to flashlights; disposition of seized registrations and driver's licenses; investigation and disposition of abandoned vehicles; conduct traffic studies for volume and speed; specialized traffic enforcement e.g., commercial motor vehicles; car seat checks and installation as well as acting as Quartermaster.

## Community Policing Unit

**The mission** of the Haverford Township Police Department Community Policing Unit is to provide information to the public so it can be informed of current crime trends and have a basic understanding of how to reduce their risk of victimization.

The Community Policing Unit is comprised of one (1) Sergeant and two (2) Patrol Officers. The members of the unit are all Certified Crime Prevention Specialists. Members of this unit provide support to the Patrol Division and Detective Unit, as well as the community. It works closely with the residential, commercial and

industrial communities and develops strategies that promote proactive community problem solving and crime prevention.

**The foundation** of a successful community policing strategy is the close, interactive relationship between officers and community members working toward the goal of reducing crime and its effects. Efforts focus on the underlying causes of crime by assessing the characteristics of problems in specific neighborhoods and the application of appropriate, mutually supported problem-solving remedies in a partnership role.

Crime prevention officers work closely with all community groups such as Local Civic Associations, Optimist Clubs, Rotary Club, Church groups, Boys and Girl Scout troops and Neighborhood organizations with Community based safety presentations and programs. Additionally the unit is responsible for presenting a wide range of safety and education programs to students in the Haverford Township School District and Parochial Schools.

**The most notable** change for 2008 was the termination of the D.A.R.E. program in the schools. Due to the limited amount of funds received from the Pennsylvania Commission on Crime and Delinquency and the rising costs of the program, the Police Department had to reevaluate the structure of the School Based Initiatives, and which programs would be able to be presented to the schools. The ability to present the DARE curriculum had become a burden on the department both in a financial and manpower capacity. The decision to terminate this long standing program was not made easily and without concerns voiced by many citizens and school officials. The Police Department's commitment to the School Based Initiatives continued and a new program was developed by Patrolman Michael Flynn and Patrolman Vincent Rondolone. This new program named R.E.A.C.H. (**R**ealistic **E**ducation **t**o **A**void **C**rime **a**nd **H**arm) provides twelve 45-60 minute lessons on personal safety topics ranging from, the effects of alcohol & drugs to internet safety. The program includes topics such as communication styles, decision making skills and positive alternatives. This new program has the flexibility to be presented to any grade level. The R.E.A.C.H. program was presented in twenty-six (26) classes throughout all schools in the Township.

Community Policing Unit Officers are certified Crime Prevention Specialists and C.E.P.T.E.D. (Crime Prevention Through Environmental Design) Specialists who are available to provide residents and business owners with security surveys to help reduce crimes against persons and property. These surveys are free of charge and highlight areas of potential vulnerability and strengths observed by the officers completing the survey. The property owner is then provided a written and verbal report discussing the results of the survey.

**An additional responsibility** of the CPU is the coordination of the police department motorcycle officers and events. The department owns and operates four motorcycles, two (2) 2002 Harley-Davidson Road King, one (1) 2003 Harley-Davidson Road King and one (1) 2003 Harley-Davidson Electra-Glide. The motorcycles may be utilized in many various aspects of police work however they are primarily used for traffic enforcement and routine patrol. The department also provides police motorcycle escorts and traffic control for visiting dignitaries, large funerals, parades and special events.

**There are four Patrol Officers**, one SOU Officer and the CPU Sergeant certified as Police Motorcycle Operators. Sergeant Michael Glenn and Officer John Esher have been certified through Northwestern University and Harley-Davidson as Basic Police Motorcycle Operator Instructors. These instructors work in conjunction with the Montgomery County Chief's of Police Emergency Driver Training Program, to certify the department's officers as Police Motorcycle Operators. Through this program Motorcycle Officers receive bi-annual training and recertification. The recertification program helps to refine the coordination, skills and confidence necessary for the motor officer to continue to operate a police motorcycle safely and efficiently. In this training, braking exercises and hazard avoidance are stressed. Additional skills include pair & group riding, escort procedures and other various slow riding skills are also practiced.

**The Safety/Meter Enforcement Office** is under the direction of the Sergeant of the Community Policing Unit and is responsible for all of the school crossings within the Township as well as parking meter enforcement. The office is staffed by one secretary and seven part time meter enforcement officers.

Throughout the township are 416 parking meters, these meters are located within five different municipal parking lots and curbside parking spaces at several different business districts. These meters are maintained and serviced by Meter Enforcement Officers, who are also responsible for the coin collection from these meters. This year saw the retirement of two of our meter officers, Joan Aurig and Edward Pumphreys. Our current complement of school crossing guards is down from eighty two to the current level of sixty five guards.

There were a total of 3,302 parking tickets issued in 2008. Meter Enforcement Officers issued 2,285 of those parking tickets. Collections from meters totaled \$100,759.35. This amount was a decrease from the 2007 amount of \$101,912.41. The police department sold 37 municipal parking lot stickers for a total of \$11,163.00 which is a decrease from the 2007 amount of \$11,844.50. Fines collected for parking violation citations totaled \$43,010.00 in 2008, which was a decrease from \$45,155.00 in 2007. The decrease in revenue and tickets issued may be due to the closure of the Oakmont Lot during the construction of the Oakmont Fire Company building and the reduction of Meter Enforcement personnel.

## Critical Incident Team (CIT)

The Critical Incident Team is a specialized group of highly trained officers that are utilized by this department to respond to the most dangerous and critical incidents in the township and surrounding jurisdictions when requested. These officers are divided among two teams the Special Response Team and the Crisis Negotiations Team.

### Special Response Team

The Special Response Team is the department's tactical team. The officers that comprise the Special Response Team are all highly trained and motivated officers who are tasked with resolving critical incidents through the use of specialized weapons and tactics.

In 2008 the SRT continued to hone their tactical skills by participating in Delaware County's Community Preparedness Program. This year's program, which is coordinated through the Delaware County District Attorney's office, focused on a multi jurisdictional training effort called the Corridor Counter

Terrorism Exercise. The exercise brought the county's various police tactical teams, bomb squad, Federal Bureau of Investigations, Coast Guard, Philadelphia and Marcus Hook Marine Units together to train at high value locations that may be targeted by foreign or domestic terrorists.

The police department is able to utilize four current officers as certified instructors in various police sciences pertaining to tactical operations. Sergeant Joseph Hagan along with Patrol Officers John Esher and Stephen Birney are certified NRA firearms instructors. Officer Michael Flynn is an internationally recognized instructor in Tactical Team Development receiving his certification from Heckler & Koch International Training Division. These certifications allow the department to develop and provide high quality in-house training to enhance and expand the Special Response Teams capabilities. These trainings are coordinated through the Special Operations Sergeant, Sergeant Joseph Hagan.

This year the Special Response Team as a group and individually received over 1160 hours of specialized training. The training consisted of practice in basic tactical movement, firearms, less than lethal weapons, and specialized tools including hazmat suits, distraction devices and deployment of chemical agents.

### Crisis Negotiation Team

The police department also maintains a Crisis Negotiation Team. The Crisis Negotiation Team is responsible for resolving critical incidents through the use of specialized negotiation tactics. The team is coordinated by Sergeant Shant Bedrossian.

All the members of the Crisis Negotiation Team have received training from the Federal Bureau of Investigations along with the Law Enforcement Officers Training School in basic crisis negotiations. Several of the team members have also received training in Advanced Negotiations and Specialized Negotiations from the Federal Bureau of Investigations and the Law Enforcement Officers Training School.

In 2008 the Crisis Negotiations Team sharpened their skills by attending the Federal Bureau of Investigations conference on negotiations held in Baltimore Maryland. This conference covered the newest techniques and trends in resolving critical incidents.

The team also conducted regular in-house and scenario based training to enhance the readiness of the negotiations team. In 2008 the Crisis Negotiations Team was able to conduct joint training with the Special Response Team to provide real world practice in resolving critical incidents. This joint training allowed officers the opportunity to deploy and resolve a scenario driven incident giving them practical hands on experience.

## Staff Services Division

**T**he Staff Services Division is the information center within the police department. The division is comprised of two units, the Records Unit and the Information Assistant Office. The division is overseen by one Sergeant who leads eleven civilian personnel.

### The Records Unit

Records Unit is a component of the Staff Services Division. It is staffed by both police and civilian personnel who are committed to providing professional service to the public. It maintains all reports generated by the officers; which includes arrest reports, incident reports, crash reports, citations (traffic and non-traffic) and parking tickets. It also coordinates with the courts in scheduling hearings for the officers.

**In 2006**, the Police Department upgraded its Records Management System (RMS) from the AS/400 database system to Visual Alert. This project was a two year process which allowed the Records Unit to run more efficiently and provided instant access to all incident information. This new system enables officers to complete reports and enter them directly into the RMS and gives officers the immediate access to information in conducting investigations. It also manages alarm billing and processes parking citations.

**In 2008**, the Records Unit provided information from over 18,000 police events to persons requesting information. In addition, the unit provides reports to state and federal agencies.

### Information Assistant Office

Haverford Township Police Department maintained a Communication Center since 1916 for Police, Fire and EMS services. Over the years many significant procedural and technological changes have been made. Until the early 1970's the Communications Center was staffed by sworn Police personnel. The 70's brought civilian personnel (Dispatchers) to the department. These dispatchers worked in

the Radio Room along with the Duty Sergeant. Along the way the Duty Sergeant was replaced with a second civilian dispatcher. Many other communication changes have occurred over the years such as going from an AT&T PBX board to an advanced 911 Phone System along with instituting a mobile and portable radio system. During the 1990's all Personnel assigned to the communications center received certificates in Telecommunication and Emergency Medical Dispatch training courses.

In 2008 due to increasing technical and financial requirements to maintain a communications center Township Officials made the decision to transfer its 911 operations to Delaware County Communications Center. Joint efforts between County and Township personnel allowed for a seamless transition that was accomplished on November 5, 2008. Five of our highly trained and long term dispatchers remained within the department in our newly created Information Assistant office as Information Assistants to handle in house communication, prisoner supervision, coordination between the police department and other township services as well as report/ data entry into the records management system.

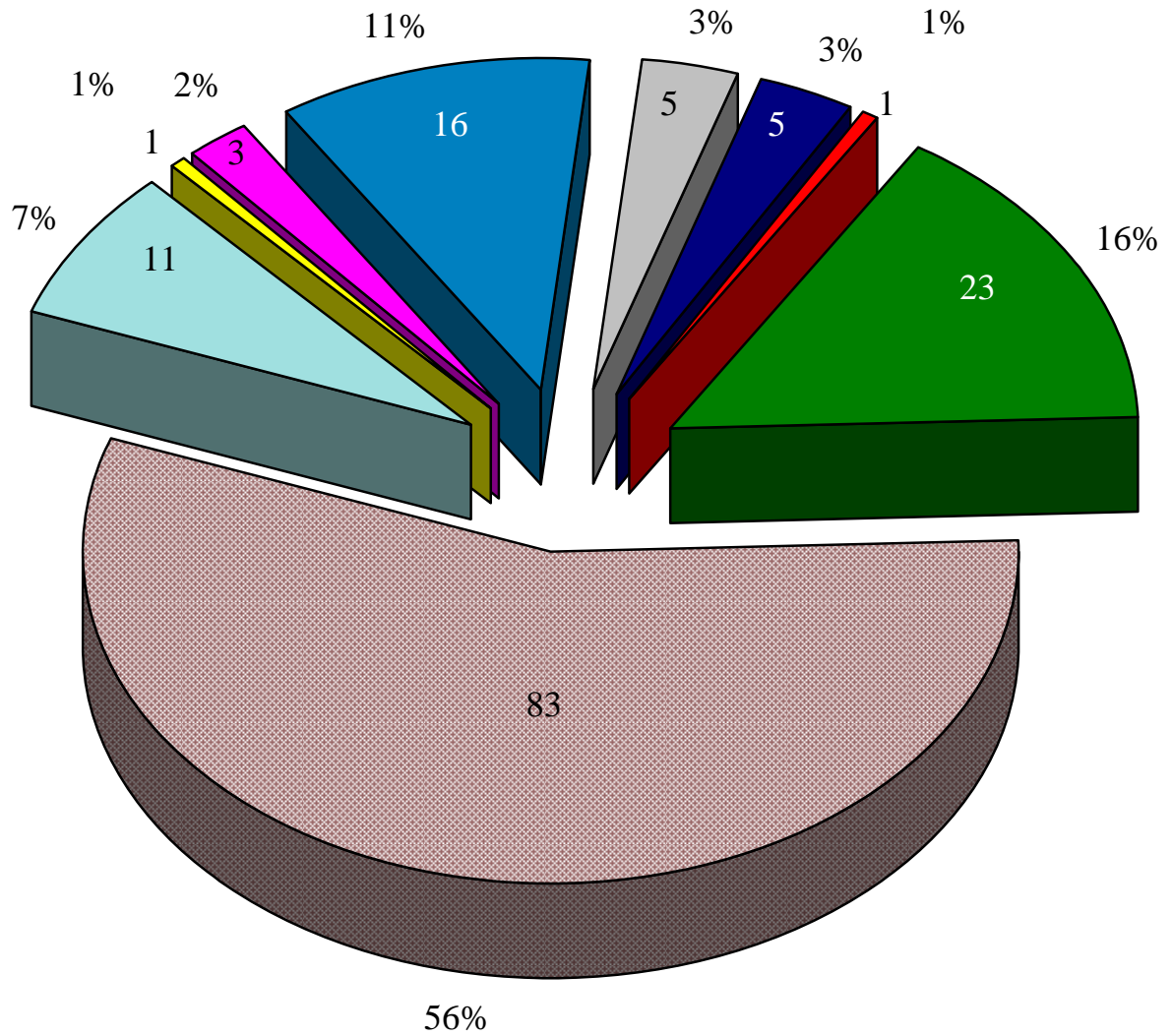

However as with all systems of information there may be minor discrepancies due to different record keeping procedures.

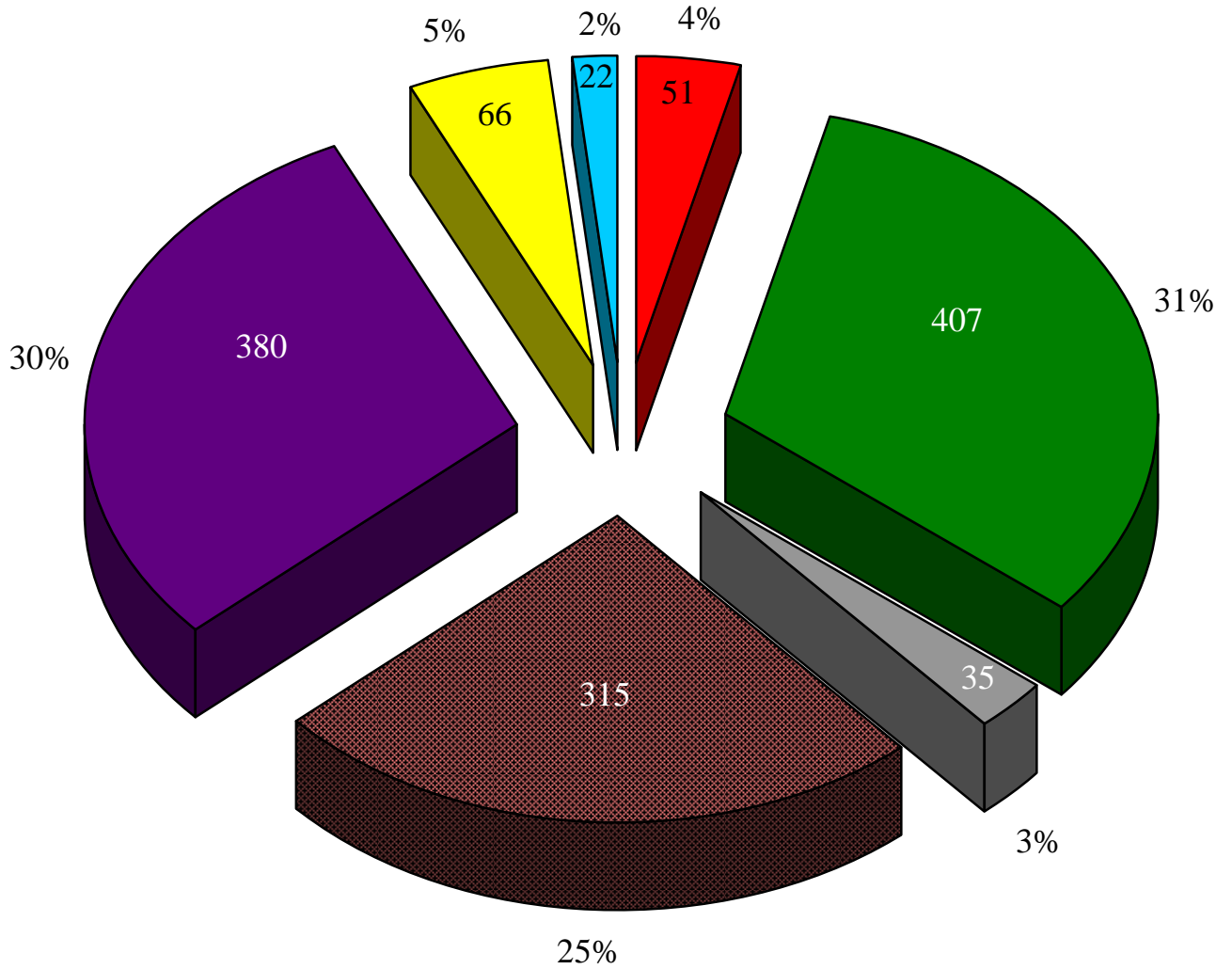

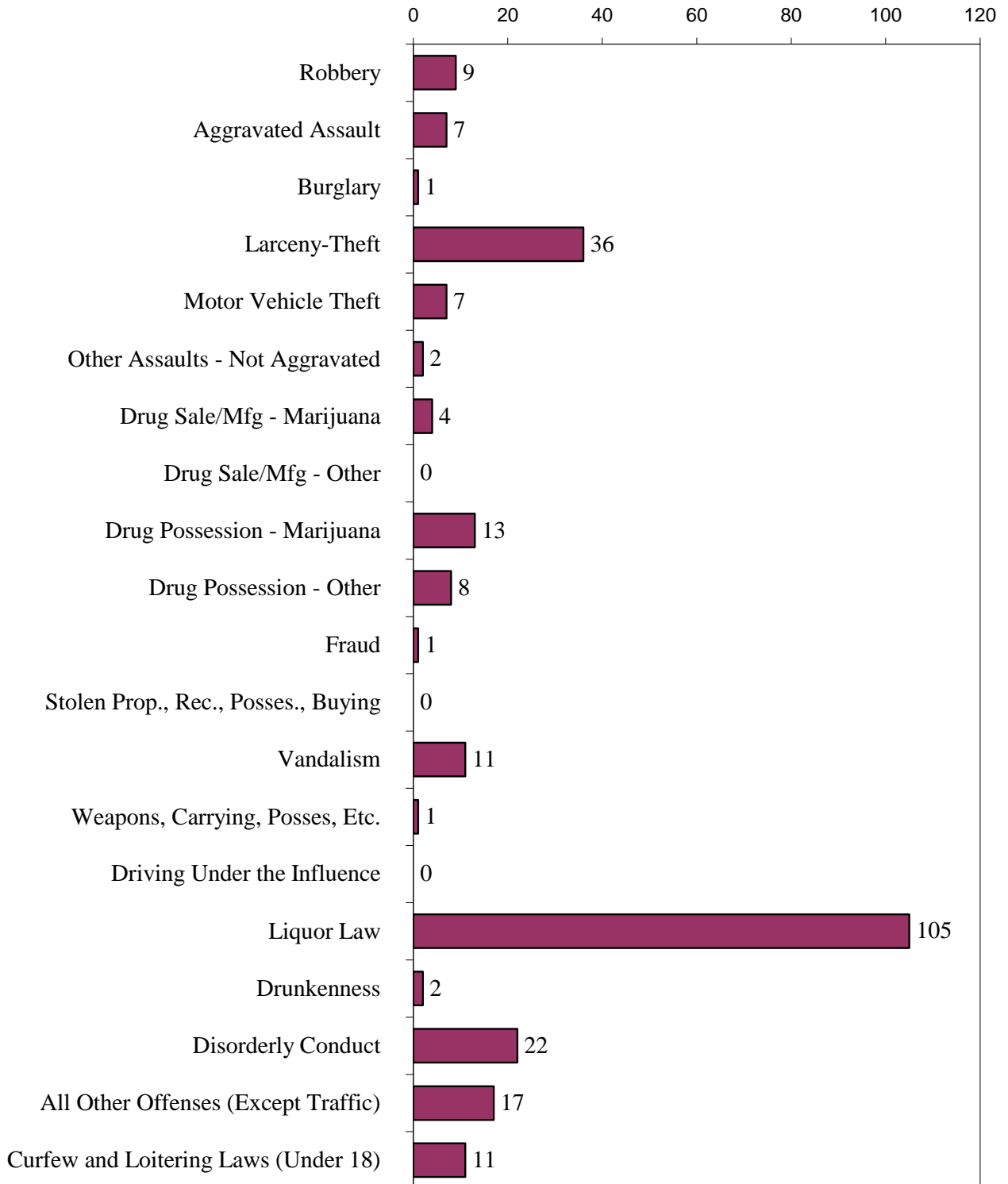

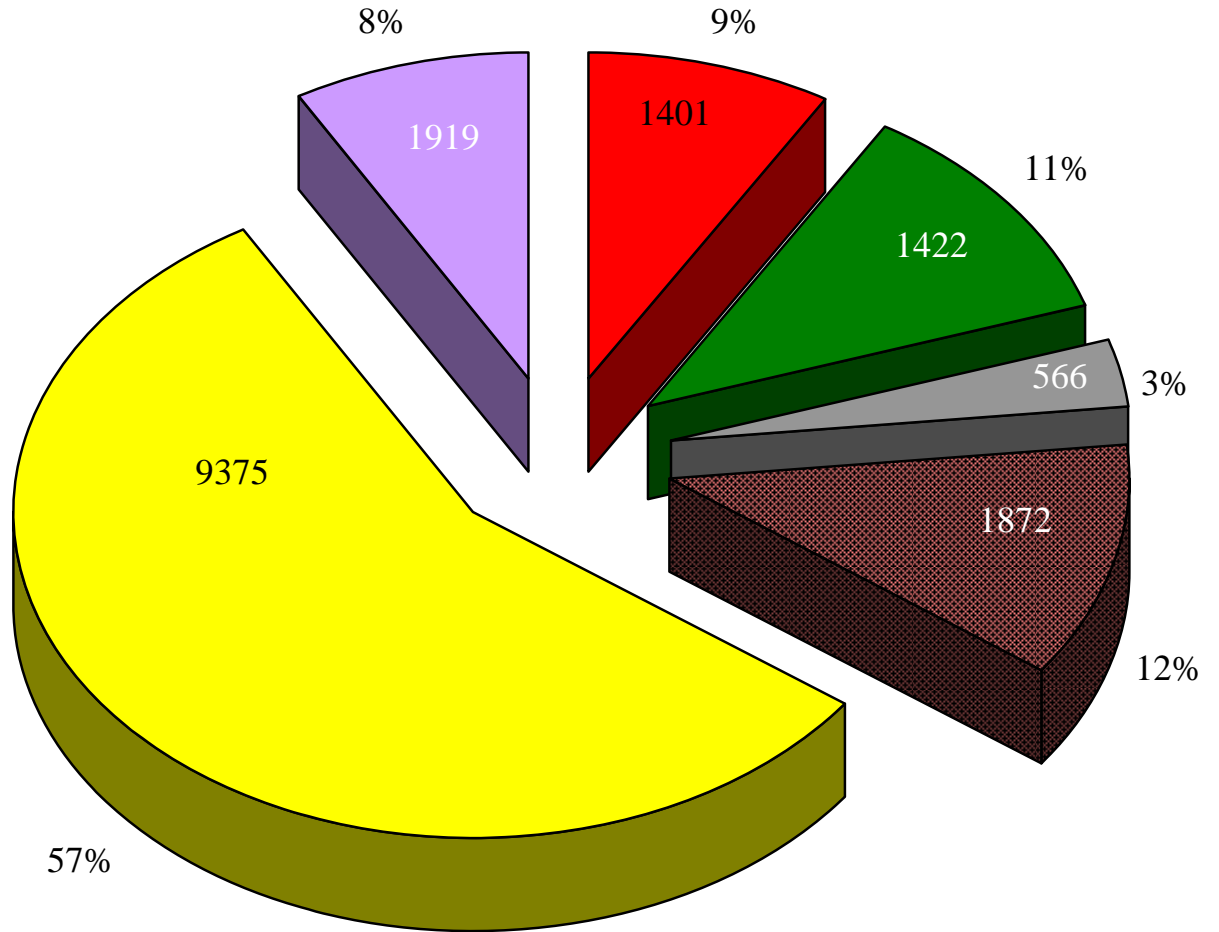

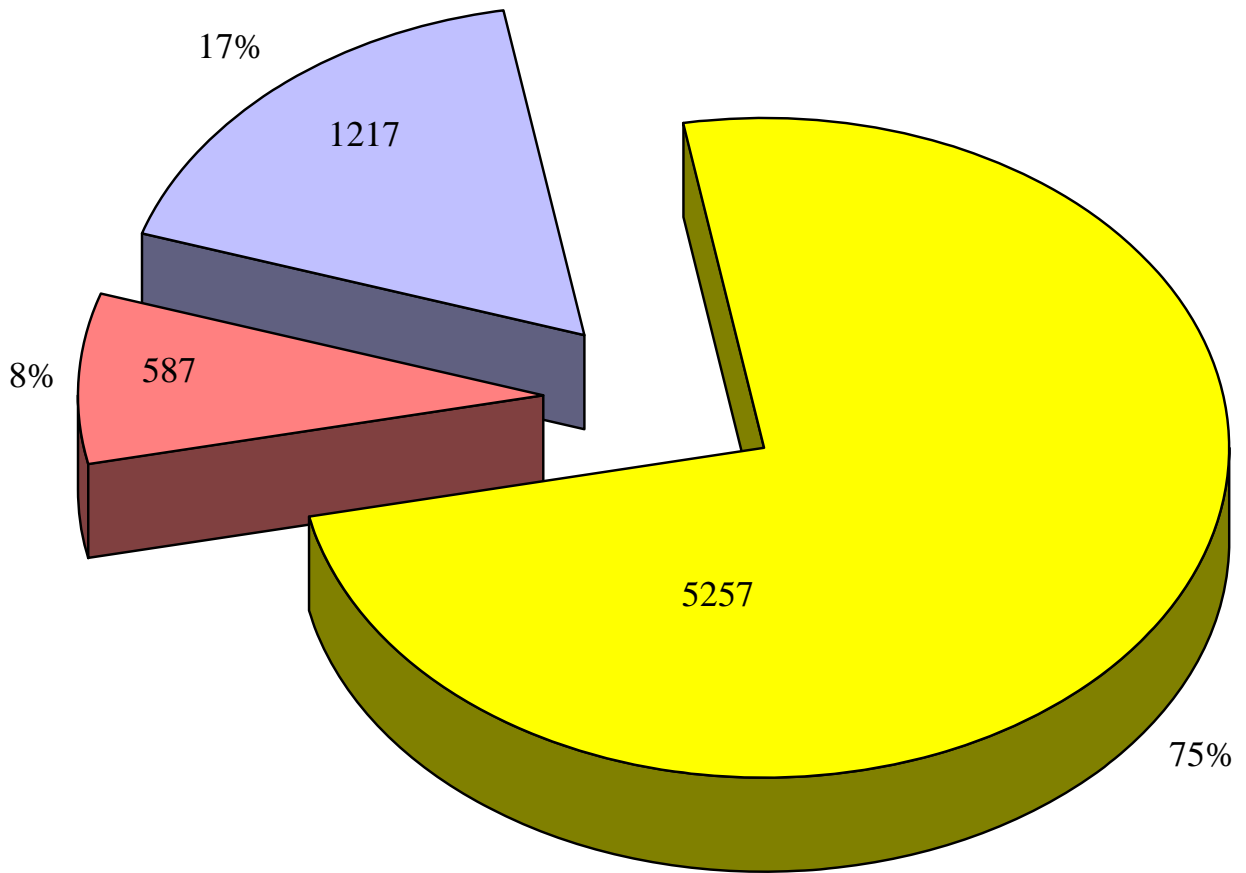

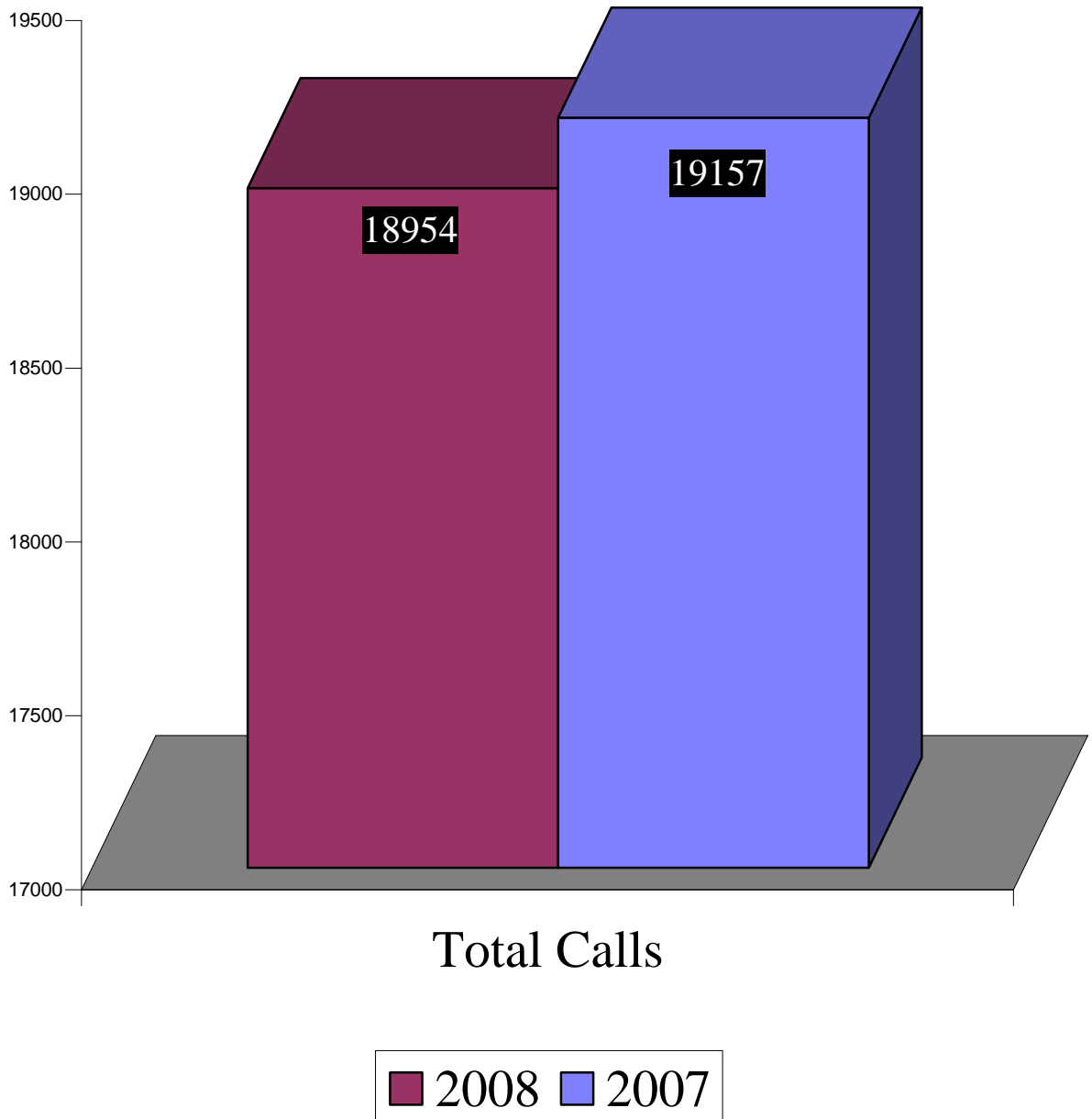

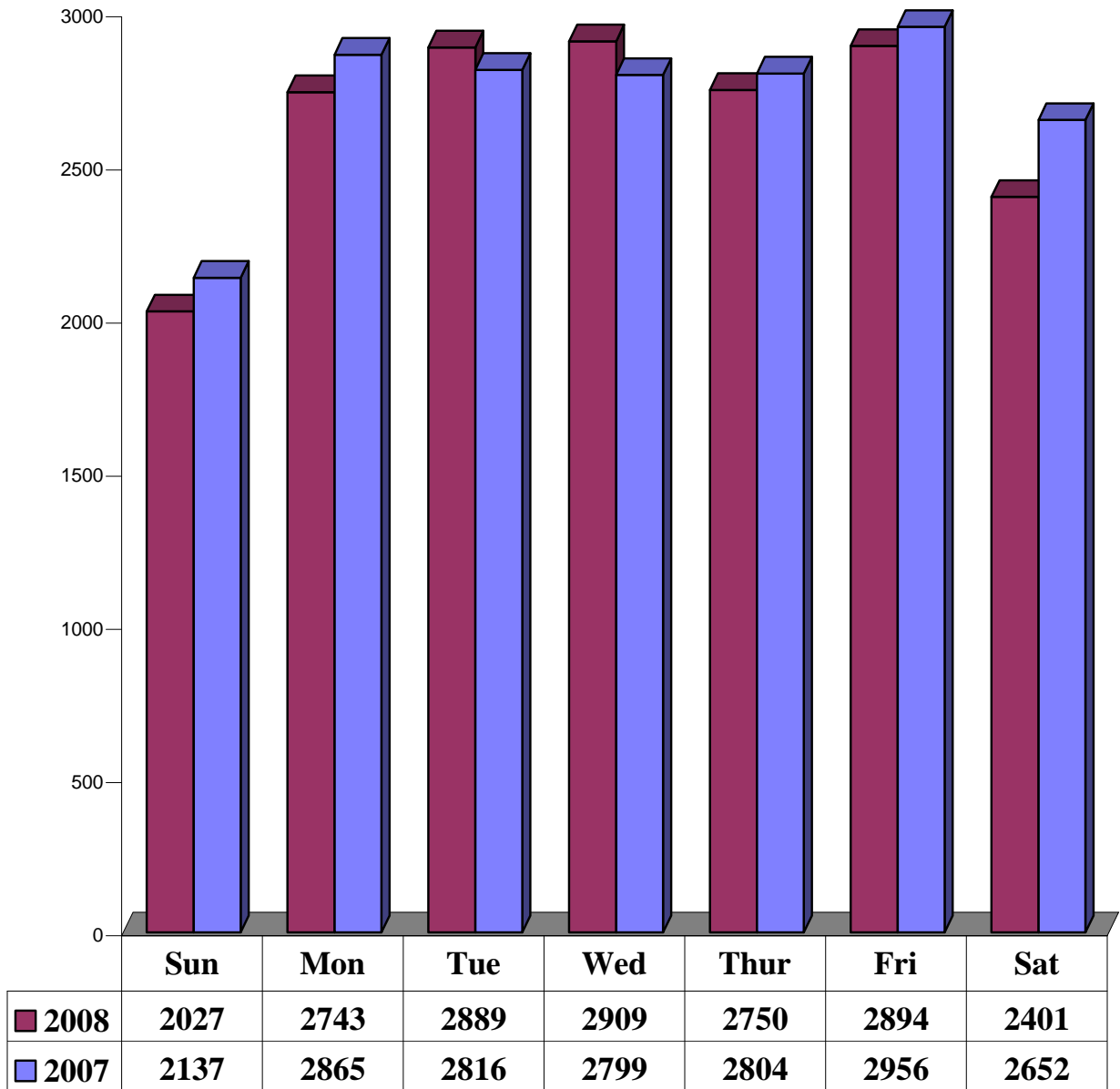
### Two Year Comparison

### Two Year Comparison

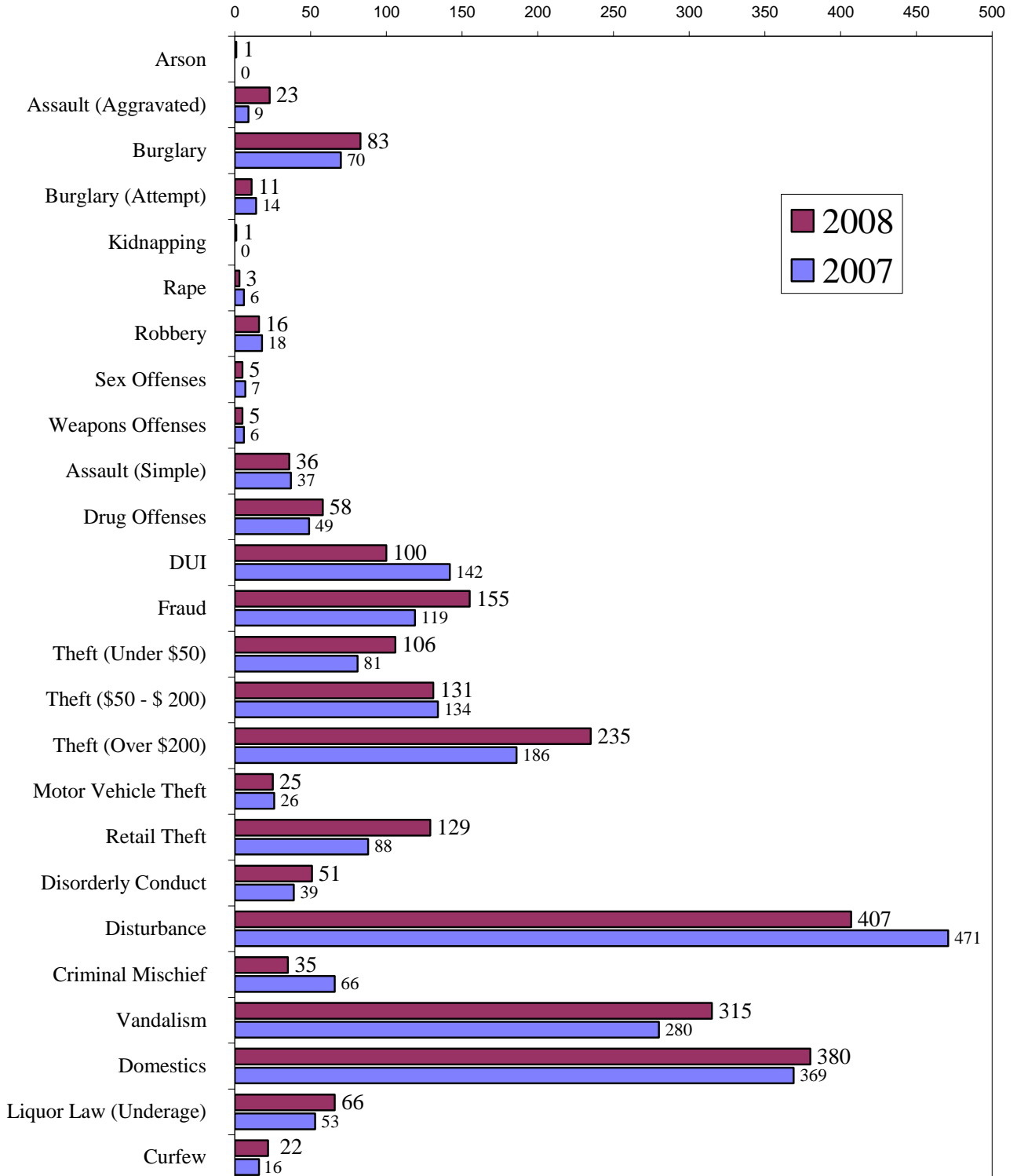

## All Crimes Two Year Comparison

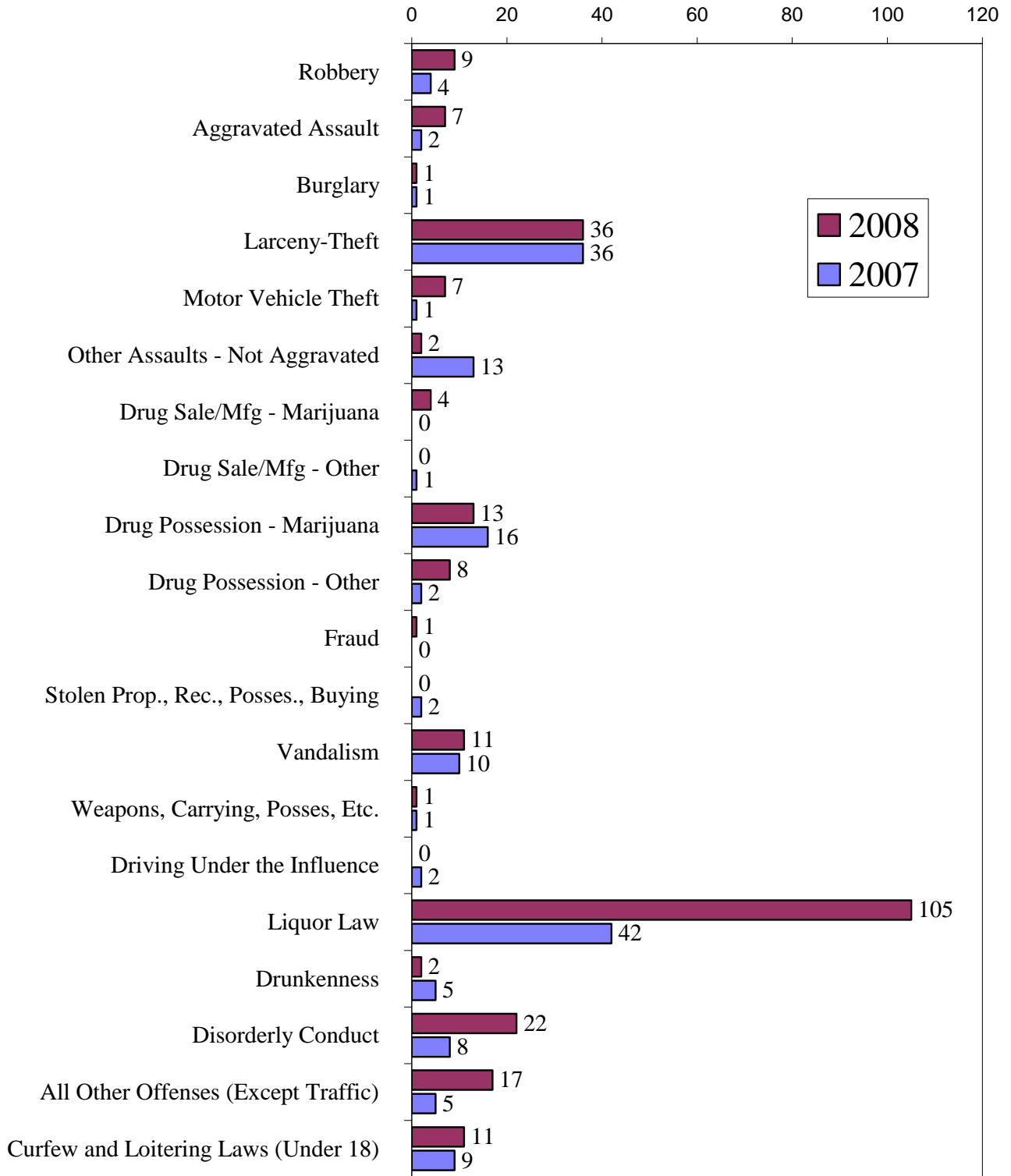

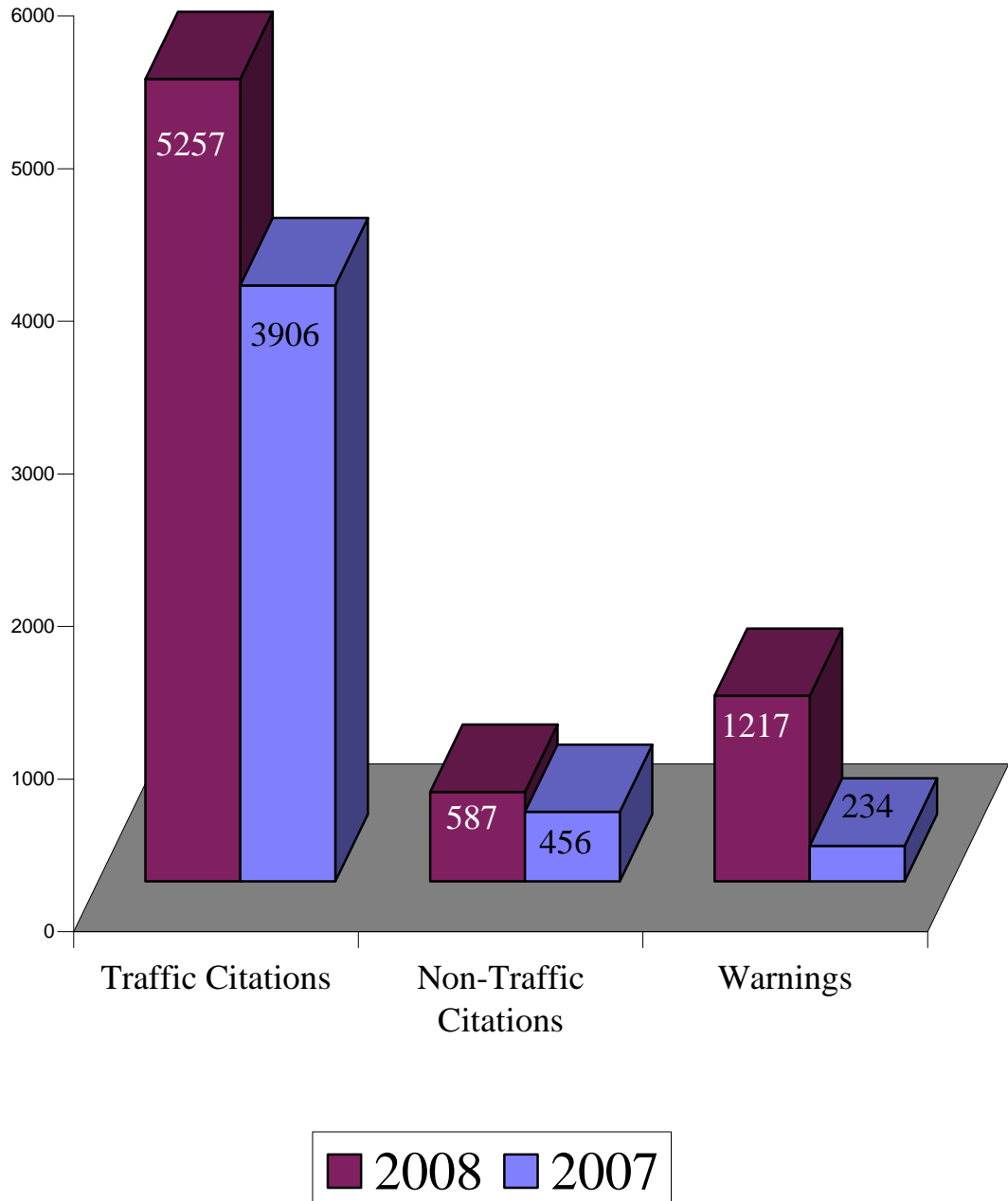

### Two Year Comparison

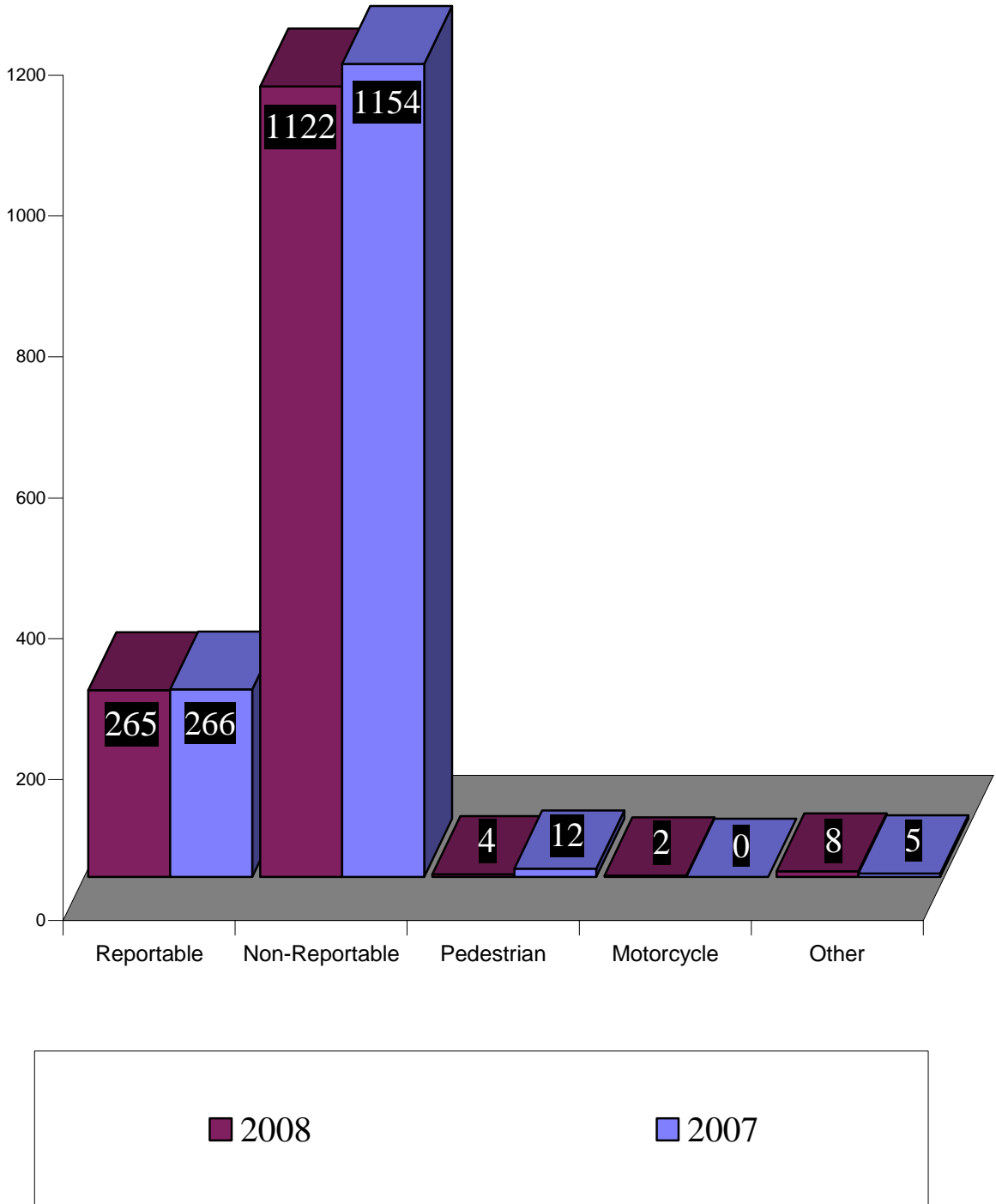


# Haverford Township Police Citations Two Year Comparison 2008 & 2007
